North Grayhawk Green Space Improvement

The Grayhawk HOA made improvements to an area north of Panther Creek Parkway under the City of Frisco powerline right-of-way. An irrigation system was added to help maintain the green space below the powerline. Photos below show the irrigation pipes being laid and the completed project. The grass will fill in once consistent warm temperatures return, aided by the steady water supply.





Don't Get Hooked by Phishing Emails

What is phishing? According to Consumer Reports, phishing (pronounced "fishing") is a form of identity theft where hackers use fake websites and emails in an attempt to steal personal data such as passwords and credit card information. Phishing emails are on the rise and scammers are always thinking of new and creative ways to steal personal data.

SBB Management Company, who manages the Grayhawk Homeowners Association, will <u>not</u> email homeowners asking for personal information such as credit card information or social security numbers. The new upgraded SBB web portal allows homeowners to select their preferred method of communication (email or regular mail). If you opt for communications via regular mail and receive an email appearing to be from SBB Management Company, be sure to check the email carefully before clicking on links or opening any attachments.

Common indicators of a phishing email include a general salutation such as "Dear Sir or Madam," and a sender's email address that is close but not exact (may end in .co instead of .com). If you have a question about an email you receive from SBB Management Company, contact our property manager Betty Crudden. Her contact information is at the bottom of this email.

Per Consumer Reports, if you are not 100% certain of an email's authenticity, do not click on an attachment or embedded link. For more information on phishing emails and texts and how to
